**Minutes of the Annual Community Council Meeting held on Monday,  
15th May 2017 at the Old School, Mochdre at 7.00pm.**

**MINUTES**

1. Newly elected Councillors signed "Declarations of Acceptance of Office" and written undertakings to observe the Code of Conduct, duly witnessed and signed by the Clerk.  
**ACTION:** The Clerk will send these to the Ombudsman and also copies to Wyn Richards, Head of Legal Scrutiny and Democratic Services.
2. Election of Chairman - The outgoing Chairman Cllr Russell Williams called for nominations. Cllr Philip Williams proposed Cllr Russell Williams, This was seconded by Cllr Jean Williams and, there being no other nominations, Cllr Russell Williams was re-elected as Chairman for the ensuing year. The newly re-elected Chairman then signed his "Declaration of Acceptance of Office".
3. The Chairman welcomed everyone to the meeting, including newly elected County Cllr Karl Lewis, and congratulated him on his election success.
4. Attendance and Apologies for absence – There were no apologies for absence.
5. Election of Vice Chairman – The Chairman called for nominations for Vice Chairman. Cllr Gordon Jones proposed Cllr Robin Lewis. This was seconded by Cllr Philip Williams. There being no other nominations, Cllr Robin Lewis was duly re-elected as Vice Chairman for the ensuing year.
6. To appoint cheque signatories - all councillors will be signatories.  
**ACTION:** The Clerk will get the Bank Mandate amended to remove past Councillors and cover new Councillors.
7. Planning Committee - Cllrs Gordon Jones, Jean Williams and Philip Williams agreed to continue to serve, with the new addition of Cllr Martin Turley. Cllrs Robin Lewis and Russell Williams agreed to be joint reserves.
8. One Voice Wales Montgomery Area Committee - Cllr Russell Williams agreed to continue to serve, with the addition of Cllr Jean Williams. Cllr Martin Turley agreed to be reserve.
9. Area C Community Benefits Committee (ACCB) - Cllr Robin Lewis agreed to continue to serve.
10. The Council considered if it wished to nominate a Councillor to become a rep on Powys County Council Standards Community Sub Committee and decided it did not wish to at this time.
11. All Declarations of Acceptance of Office and written undertakings to observe the Code of Conduct have been duly received at this meeting – there are none outstanding.
