- 2.0. Confirmation of Minutes of the last council Meeting and the Interim Community Council Planning Meeting held on 17th November, 2014 (previously circulated).

# 3.0. Information from the Minutes.

- 3.1. Newtown Bypass Draft Orders Residents of Glandulas, Bontdulas and Brook Terrace attended to discuss this matter. Hilary Kewley gave an overview on what she has been doing and what has been happening since May 2014. She also produced packs of useful information for distribution to those concerned. After discussion the consensus of the residents was that the Orange Route is neither environmentally nor economically the best route, and asked the Council to write to WAG in support of their concerns.

- 6.1. Application Ref: DECC2014 0022 For section 37 consent of the Electricity Act 1989 to keep installed an 11kv overhead line (retrospective) at Land at Craig Dugwm, Nr Dugwm Farm, Mochdre E-mailed to Councillors on 24/11/14 prior to the deadline (5th December, 2014). There were no comments.
- **6.2.** Notice to Remove Hedgerows ref: HEDG/2014/0007 in respect of Application for hedgerow removal at fields east of Lower Talwrn, Stepaside, Mochdre, Powys (308575.18/289722.27) E-mailed to Councillors on 30/10/14 prior to the deadline (5th December, 2014). There were no comments.
- **6.3.** Further Letter from E. Hikins re. Dugwm Turbine Planning Application Received on 19/11/14 and e-mailed to Councillors for information. Duly noted.
